

WORKERS' COMPENSATION POSTING NOTICES: WHAT YOU NEED TO KNOW

If you provide workers' compensation coverage, most states require that a poster be displayed in a conspicuous location for your employees to be informed of their workers' compensation rights.

HOW TO GET YOUR NOTICES

There are several ways to get your posting notices.



By mail. As a customer of The Hartford, you'll get all your required notices in the mail with your workers' comp policy documents.



By phone. Call us at 315-235-0822.



Online. For faster access to your notices, log in [here](#). They'll be ready to go with your business information filled in after your policy has issued, so all you need to do is print them and put them up. Not registered yet? It's quick and easy to set up your account.
